Fair Book Updates: Discussion took place regarding two fair book changes that are to be added and edited to the fair book.

A motion was made by Becca Walter to add this following note regarding mandatory meetings be added to the Fair Book:

"All exhibitors that are looking to participate, regardless of species, in the Junior Livestock Sale **MUST** attend one of the two mandatory meetings hosted by the sale committee in late spring and early summer. A parent or guardian may also attend in the exhibitor's absence; no other outside parties (i.e. 4-H leaders, friends, or extended family) may pick up the packets. Failure to attend one of these meetings will result in the exhibitor being ineligible to participate in the Junior Livestock Sale. If unable to attend one of the mandatory meetings, the Chair or Vice Chair of the Junior Livestock Sale Committee must be notified by April 1st; it will then be up to the discretion of the entire voting committee if the exhibitor may receive an alternative option."

The motion was seconded by Brett Shreve. A vote occurred and the majority passed the addition to the Fair Book.

A motion was made by Brett Shreve to edit the following note regarding checks being picked up by exhibitors to the Fair Book:

"All checks not claimed within 90 days of arrival at The Ranch Events Office will be returned to the Larimer County Finance office. Ranch staff will be responsible for reminding exhibitors one additional time after the 60-day period if their checks have still not been claimed."

The motion was seconded by Jenny Brown. A vote occurred and the majority passed the edit to the Fair Book.

Moving Sale: A question was raised by Bailey Schilling regarding moving the sale from a Wednesday to a Thursday to save the sale committee from paying for an auctioneer.

Discussion occurred and the committee determined that it was not feasible to hold animals longer and extend the time of animals at the Ranch as other events occur immediately after the fair.

Volgistics: Tanner mentioned Volgistics hours need to be logged, and will be tracked for this year until the end of December

Sale Committee Applications: Tanner noted that applications for committee members can start to be received.
