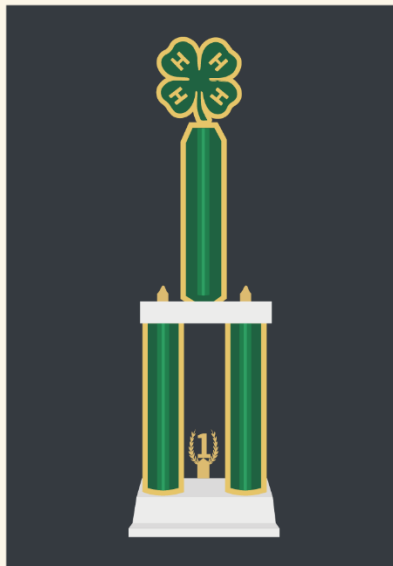


# OPEN CLASS FAIR BOOK



# Instructions on How to Enter Open Class Exhibits

- 1. Fair Book:** The Fair Book contains all the entry guidelines, classes and descriptions. Access the 2024 Larimer County Fair Book online at: <https://www.treventscomplex.com/events/larimer-county-fair/4-h-and-open-class>. Each department is listed separately. Information follows regarding this specific department. Printed Fair Books may be requested from the Competitions Coordinator at 970-619-4023, [boldtla@larimer.org](mailto:boldtla@larimer.org)
- 2. Schedule:** Read the Open Class Schedule at the end of this document.
- 3. General Information:** Read the general information and rules and follow the specific information for departments. **Photography exhibitors should be sure to understand and follow the rules for size and mounting of photos before arriving at check-in.**
- 4. Exhibitors** do not need to be Larimer County residents to enter.
- 5. Online Entry:** Complete the Open Class Registration online through Fair Entry (not 4-H online) <https://faireentry.com/Fair/SignIn/19828>. If you entered last year, you are in the Fair Entry System as an exhibitor and you just need to add classes. If you are a new exhibitor, please sign up as such and follow the prompts to set you up as an exhibitor. Then add your classes. Everyone should make sure to hit the submit button and receive confirmation of your entries.
- 6. Entry:** Pre-Registration Entry is recommended in all departments through an on-line Fair Entry system beginning **Friday, March 1<sup>st</sup> through Tuesday, July 23<sup>rd</sup> at 11:50 pm**. Written entry forms can be requested through the Competitions Coordinator at 970-619-4023, [boldtla@larimer.org](mailto:boldtla@larimer.org). Printed entries can be emailed, delivered or mailed to the Larimer County Fair Office, 5280 Arena Circle, Ste #100, Loveland, CO 80538. Entry Office opens at 8:30 a.m. and closes at 4:30 p.m. Postmarks, faxes, or email pre-registration will be accepted only if posted on or before July 23rd at 4:30 pm.
- 7. Late Registration** – Late Entries Taken at Department Check-In, Tuesday, July 30th. Horticulture late entries will be accepted on Wednesday, July 31<sup>st</sup> from 7:30 a.m. – 10:00 a.m.
- 8. Check-In** – Park in the McKee Building parking lot or Lot A or B then enter on the Northeast doors in South Hall of the 1st National Bank building at The Ranch. Open Class exhibits (exception Horticulture) must be received **Tuesday, July 30<sup>th</sup> between 4:00 p.m. and 7:00 p.m.** Horticulture exhibits check-in Wednesday, July 31st between 7:30 a.m. and 10:00 a.m. At check-in, arrive in time to receive your exhibitor identification tag(s). Review the information on the I.D. tag and assign one tag to each exhibit. Take exhibit(s) to the respective departments.
- 9. Check-Out** - Please return to The Ranch South Hall of the 1<sup>st</sup> National Bank building to pick up your exhibits on **Wednesday, August 7 between 4:00 p.m. and 7:00 p.m.** Collect any awards won. **If you are unable to pick up your exhibits that evening, please have someone else do it for you.** Removal of any exhibit before the designated time requires written approval from the Superintendent or Exhibitor Coordinator. Violation of this rule shall cause the exhibitor to forfeit any awards due to him or her.
- 10. Judging** - Viewing of judging is open to the public. You are welcome to listen and learn from the judges.
- All products exhibited must have been prepared since August 1, 2023, except for quilts or photography. Exhibits can be entered only once.
- Any article may be tested to the satisfaction of the judges. All articles and garments entered must be clean.
- Children's age is determined as of December 31, 2023.
- Only one entry will be accepted in each class from each exhibitor except Fine Arts, Photography, and Spinning and Weaving. No Champion or Reserve Champion will be awarded if the exhibit is not worthy.
- Special awards will be chosen at the discretion of the judge(s) in each department and coordinated through the Superintendents.
- All exhibits must remain on exhibit for the entire Fair, regardless of whether an award is given.
- 17. Special Awards** - Exhibitors may collect special awards for department winners. Collection of the award is as follows: Wednesday, August 7th 4:00 p.m. – 7:00 p.m. Otherwise at the Ranch Administration office Thursday, August 8th, 8:30 am – 4:30 p.m. and Friday, August 9th 8:30 a.m. – noon. Special awards not collected will be forfeited. No Exceptions.
- 18. Premiums/Money** - Premiums will be given for class placement in youth designated classes. No money is awarded for general/adult classes.
- 19. The use of marijuana or CBD in any display, food item, or exhibit is prohibited and shall be rejected.**
- Classes may be combined or divided at the discretion of the superintendents. If there are 3 or more items in a miscellaneous or "Any Other" class, a new class may be made.

### Open Class Horticulture Garden Flowers Rules

#### Key dates and times:

**Entry for Garden Flower exhibits: Wednesday, July 31st, 7:30 a.m. to 10:00 a.m.**

**Judging time for Garden Flower exhibits: Wednesday, July 31st, 10:30 a.m. to 12:30 p.m.**

**Check-out for Garden Flower exhibits: Wednesday, August 7, 4:00 p.m. to 7:00 p.m.**

- 1. All flowers used in entries, including fresh flower arrangements, must be grown by the exhibitor. Store-bought flowers are prohibited. All arrangements must be fresh not dried.**
2. Exhibits must be checked in with the superintendent and in place between 7:30 a.m. – 10:00 a.m. on July 31st.
3. Exhibits must remain on display through Tuesday, August 6. If not removed by 7:00 p.m., August 7 they will be disposed of by Fair Management.
4. Judging will start promptly at **10:30 a.m.**, Wednesday, July 31st, and is open to the public to hear judges' comments.
5. At check-in time on July 31st, your department's exhibitor's number will be given to you. At that time, each exhibitor will verify his or her own individual class entry tags and place them on their exhibits. A list of these entries should be given to the Superintendent for checking.
- 6. Please write variety of the flower, if known, on the entry tag. If entering more than one variety in a single class, the name of each variety is required to be written on the tag.**
7. Unworthy exhibits and exhibits which do not follow the class description will be disqualified. Exhibits will be displayed and presented to the Judge by Superintendents and/or assistants in charge of this department.
8. Classes may be combined or divided at the discretion of the Superintendents. If there are 3 or more exhibits in an "any other" class, a new class may be made.
9. Exhibitors may keep flowers in good condition during the Fair by replacing flowers when necessary and maintaining water levels.
10. Entering exhibits in the proper class is the exhibitor's responsibility. If exhibitors have questions regarding plant identification, it is encouraged that you contact the Extension Office prior to entry.
11. If a class specifies one variety, all blooms, stems, or spikes must be one color.
12. If a class requires more than one bloom, stem, or spike, but does not specify "one variety", they may be all one color or a mixture of colors.
13. An exhibitor may not exhibit more than **one** entry of the same variety in the same class. If entering more than one variety, variety must be listed on the entry tag. (See Rule 6 above.)
14. The use of marijuana or CBD in any display, food item, or exhibit is prohibited and shall be rejected. The exhibitor shall be referred to law enforcement.
15. In cut flower classes, foliage above the waterline should remain on the stem but removed if in the water. Multiple stems show best if cut at the same length.
16. All flowers must be grown by the exhibitor for at least 2 months; houseplants must be in the possession of the exhibitor for 3 months.
17. All 4-H members and other children are encouraged to enter flowers in the Open Class Garden Flower and Horticulture Show. Garden Flower classes 400 - 450 are specific for children and youth (ages 5 – 18). Youth are encouraged to enter in any other classes, as per their exhibits.
18. Awards/Champions – The Outstanding Flower Exhibit (Judge's Choice) will be picked by the Judge from any class, 110 – 450. The Outstanding Children's Exhibit (Judge's Choice) will be selected from any class, 400-420; the Outstanding Youth Exhibit (Judge's Choice) will be selected from any class, 430-450. Outstanding Flower Arrangement will be selected from classes 320-340, 420, or 450. Champions (County Flower Champion, County Flower Reserve Champion, Champion Houseplant, and Reserve Champion Houseplant) will be determined by points: First, 4 points; second, 3 points; and third, 2 points. In the event of a tie based on the points awarded, the award will be divided equally among winners.

19. **Payment of Awards:** Exhibitors may collect special awards. See Open Class Division General Rules and Regulations for schedule. Special awards not collected before noon Friday, August 9, will be forfeited. No Exceptions.

## **Open Class Horticulture Garden Flowers**

**Garden flowers will be judged based on uniformity with foliage and flowers free from insect damage and/or disease, as well as petal color and overall flower freshness.**

### **Class**

- 110. Hybrid tea rose, 1, 8" stem or longer
- 120. Any other rose, 1 variety, 3 stems, specify variety (if known)
- 130. Gladiola, 1, single spike
- 140. Zinnias, 3 stems, any variety, flowers must be the same size (i.e., all giant or pompom)
- 150. Phlox, 1, single stem
- 160. Marigold, 3 stems, any variety
- 170. Petunias, 3 stems, any flower size, one variety
- 180. Calendulas, 3 stems, one variety
- 190. Snapdragons, 3 spikes, any variety
- 200. Shasta Daisies, 3 stems
- 210. Cosmos, 3 stems, any color
- 220. Sunflower, 3 stems, one variety
- 230. Rudbeckia (black-eyed Susan), 3 stems
- 240. Echinacea (coneflower), 3 stems
- 250. Chrysanthemums, 2 sprays (multiple flowers/buds per spray)
- 260. Yarrow, 3 stems, one variety
- 270. Dahlias, 1 stem, flower size < 4" in diameter
- 280. Dahlias, 1 stem, flower size 4-6" in diameter
- 290. Dahlias, 1 stem, flower size > 6" in diameter
- 300. Daylily, 2 stems, one variety
- 310. Any other flower, 3 stems

## **Floral Arrangements**

- 320. Miniature fresh flower arrangement in any media, measuring no larger than 5" x 5"
- 330. Fresh flower arrangement or bouquet, in water or floral foam
- 340. **Foraged arrangement, in any media, materials must be collected fresh by exhibiter from any suitable outdoor area, measuring no larger than 14" tall (this arrangement may include foliage, flowers, and/or weeds)**

## **Houseplants**

- 350. Houseplants, any size container, in possession of exhibitor for at least 3 months
- 360. Houseplants, succulents or cactus only, any size container, in possession of exhibitor for at least 3 months
- 370. African Violet, any size container, in possession of exhibitor for at least 3 months
- 380. Orchid, in possession of exhibitor for at least 3 months
- 390. Fairy, dish, or terrarium garden display, with living plant material (figurines okay)

## **Children**

### **Ages 5 – 12**

- 400. Miniature fresh flower arrangement in any media, measuring no larger than 5" x 5"
- 410. Fairy, dish, or terrarium garden display, with living plant material (figurines okay)
- 420. Fresh flower arrangement or bouquet, in water or floral foam

## **Youth**

### **Ages 13 Through 18**

- 430. Miniature fresh flower arrangement in any media, measuring no larger than 5" x 5"
- 440. Fairy, dish, or terrarium garden display, with living plant material (figurines okay)
- 450. Fresh flower arrangement or bouquet, in water or floral foam

## **Open Class Horticulture Vegetables, Fruit, and Herbs Rules**

**Key dates and times:**

**Entry for Horticulture exhibits: Wednesday, July 31, 7:30 a.m. to 10:00 a.m.**

**Judging time for Horticulture exhibits: Wednesday, July 31, 1:30 p.m. to 4:30 p.m.**

**Check-out for Horticulture exhibits: Wednesday, August 7, 4:00 p.m. to 7:00 p.m.**

- 1. All entries must be grown by the exhibitor. Store-bought vegetables, fruit and herbs are prohibited.**
2. Exhibits must be checked in with the superintendent and in place between 7:30 a.m. – 10:00 a.m. on July 31st.
3. Judging will start promptly at 1:30 a.m. on Wednesday, July 31, and is open to the public to hear judges' comments.
4. At check-in time on July 31, your Department's exhibitor's number will be given to you. At that time, each exhibitor will verify their own individual class entry tags and place them on their exhibits. A list of these entries should be given to the Superintendent for checking.
5. An exhibitor may not exhibit more than **one** entry of the same variety in the same class. If entering more than one variety, variety must be listed on the entry tag.
6. Vegetable Critter Art (classes 510 and 700) – Made from any parts of vegetables or fruits, including stems, leaves, and seeds. Not to exceed 12" x 12" x 12". Fastening with glue or tape is allowed. Judged on creativity.
7. Unworthy exhibits and exhibits which do not follow the class description will be disqualified. Exhibits will be displayed and presented to the Judge by Superintendents and/or assistants in charge of this department.
8. Exhibits must remain on display through Tuesday, August 6. If not removed by 7:00 p.m., August 7 they will be disposed of by Fair Management.
9. Classes may be combined or divided at the discretion of the Superintendents. If there are 3 or more exhibits in an "any other" class, a new class may be made.
10. The use of marijuana or CBD in any display, food item, or exhibit is prohibited and shall be rejected. The exhibitor shall be referred to law enforcement.
11. Hot peppers will be the final judged exhibits. Tasting these peppers has resulted in residual heat in the mouth, making it difficult to taste/sample the entries from other classes.
12. All 4-H members and other children are encouraged to enter vegetables in the Open Class Garden Flower and Horticulture Show. Horticulture classes 510 - 540 are specific for children and youth (ages 5 – 18). Youth are encouraged to enter in any other classes, as per their exhibits.
13. Champion and Reserve Champion County Horticulture Exhibit will be determined by adding points from classes 550-830 and 950-990; Champion and Reserve Champion Herb will be determined by adding points from classes 840-940. (Points from herb classes will not count towards Horticulture Champion.) First, 4 points; second, 3 points; and third, 2 points. In the event of a tie based on the points awarded, the award will be divided equally among winners.
- 14. Payment of Awards: Exhibitors may collect special awards. See Open Class Division General Rules and Regulations for schedule. Special awards not collected before noon Friday, August 9, will be forfeited. No Exceptions..**

## Open Class Horticulture Vegetables

Vegetables will be judged for "table use." Uniformity in size, shape and color are important. Please include a variety name (if known) on entry tag.

### Class

#### (Classes for youth only; ages 5 – 18)

- 510. Vegetable Critter Art – grown by exhibitor, made from vegetables or fruits, including stems, leaves and seeds. Cannot exceed 12" in any dimension. Fastening with glue or tape is allowed.
- 520. Beans, 9 pods, with stems not more than 1" in length, any variety
- 530. Squash, 3 summer-type or zucchini, any variety
- 540. Tomatoes, 5 cherry

#### Classes for all exhibitors

- 550. Beans, 9 pods, with stems not more than 1" in length, any variety
- 560. Beets, 3 red table (topped to ½")
- 570. Broccoli, 1 head
- 580. Cabbage, 1 head, any variety
- 590. Carrots, 3 (topped to 1")
- 600. Cucumbers, 3 pickling (4" to 5" in length)
- 610. Cucumbers, 3 slicing
- 620. Eggplant, 2
- 630. Lettuce, 2 heads
- 640. Kale, any variety, 2 bunches with 2 stalks per bunch, each bundled
- 650. Any other greens, 10 leaves in a baggie
- 660. Onions, 6 green, bunched, tops may be trimmed
- 670. Onions, 3 round – or globe-type, white or yellow
- 680. Onions, 3 round – or globe-type, red
- 690. Sweet Peppers, bell type, 3
- 700. Sweet Peppers, tapered type, 3
- 710. Vegetable Critter Art – grown by exhibitor, made from vegetables or fruits, including the stems, leaves and seeds. Cannot exceed 12" in any dimension. Fastening with glue or tape is allowed.
- 720. Potatoes, 3, any variety
- 730. Pumpkin, 1, any variety
- 740. Rhubarb, 3 stalks, pulled from plant, leaf cut to 1"
- 750. Squash, 3 summer-type or zucchini, any variety
- 760. Squash, Biggest Zucchini, by weight, stem trimmed to 1"
- 770. Winter Squash, 1, any variety
- 780. Tomatoes, 5 cherry
- 790. Tomatoes, 3 green (unripe)
- 800. Tomatoes, 3 ripe
- 810. Any other vegetable, 3

## Open Class Horticulture Fruit

- 820. Apples, 3, any variety
- 830. Any other fruit: 3 (e.g., plums, peaches, pears); Small fruits, ½ cup or 4 ounces (e.g. currants, raspberries, gooseberries)

## Open Class Horticulture Herbs

- 840. Basil, 3 stems, trimmed to maximum of 10" (with leaves, in container of water)
- 850. Chives, 6 stems, trimmed to maximum of 10" (no flowers, in container of water)
- 860. Dill, seed heads only, 2 (displayed on a paper plate)
- 870. Garlic, 3 bulbs
- 880. Lavender, with flowers, 3 stems, trimmed to a maximum of 10" (in a container of water)
- 890. Mint, 3 stems, trimmed to maximum of 10" (with leaves, in container of water)
- 900. Oregano, 3 stems, trimmed to maximum of 10" (with leaves, in container of water)
- 910. Parsley, 3 stems, trimmed to maximum of 10" (with leaves, in container of water)
- 920. Rosemary, 3 stems, trimmed to a maximum of 10" (with leaves, in container of water)
- 930. Sage, 3 stems, trimmed to maximum of 10" (with leaves, in container of water)
- 940. Any other herb, 3 stems, trimmed to maximum of 10" (with leaves, in container of water)

## Open Class Horticulture Hot Peppers

**950.** Peppers, Chili – Anaheim type, 3 (limit 3 varieties per exhibitor)

**960.** Peppers, Chili – Jalapeno type, 3 (limit 3 varieties per exhibitor)

**970.** Peppers, Chili - Large, hot, 3 (limit 3 varieties per exhibitor)

**980.** Peppers, Chili - Small, hot, 3 (limit 3 varieties per exhibitor)

**990.** Hottest Pepper, any size, 1 (limit 3 varieties per exhibitor) **The hottest pepper may be chosen from any hot pepper class 950-980, or the hottest pepper class 990, at the judge's discretion.**
