
# Phase 1 of Five-Year Plan (Project completion December 2023)

- July 2023 Completion
  - Site Infrastructure: Fairgrounds Avenue reconfiguration, Arena Circle relocation, Andalusian Road construction, and Clydesdale Parkway extension
  - MAC Equipment Inc. Indoor Arena & Pavilions expansion
  - Richard Rule Road, Show Ring Road, & Pavilion Yard construction
- December 2023 Completion
  - 4-H, Youth, and Community Livestock Arena
  - Recreational Vehicle hook-up 95 spaces
  - Outdoor Arena 100' X 200'
  - Outdoor Surfaces for Stock/Trailer parking
  - Maintenance Building expansion with the relocation of the Department of Natural Resources – Land Stewardship offices


# Direction given on 11/14/2022

- Develop a Request For Proposal for a New Event Arena with an attached Youth Hockey Center with three sheets of ice
- Continue discussions with Water Valley Companies, the City of Loveland, and the Town of Windsor on off-site storm drainage
- Continue discussions with the City of Loveland on Planned Unit Development amendment processes
- Begin negotiation with Water Valley Companies on a real estate transaction for The Rocky Mountain Grand Resort
- Reevaluate options for the First National Bank of Omaha and Budweiser Event Center with a reduced scope of renovations in the Event Center
- Begin site visits to similar campuses



### Reduced scope of Budweiser Event Center renovations

- Seating replacement -Completion August 2023
- Painting interior areas including the Bowl
- Suite renovations
- Private industry commitment of \$1,000,000 to support suite renovations and other revenue generating services oncampus





### Real estate negotiation with Water Valley Companies

- Meeting with Water Valley Companies on 01/16/2023
  - Water Valley Company committed to draft a framework document for how they propose to structure an understanding
  - The Ranch staff continues to evaluate market demand and conditions for exhibition space as negotiation continues



# Stakeholder Engagement

- Equine stakeholder group
  - New business development opportunities.
- McKee kitchen expansion group
  - Investigation into current and future teaching kitchen programs & uses.
- Swim groups
  - Negotiations between Poudre School District and Fort Collins drive the location of the aquatics center. Fort Collins is exploring options for additional funding to support larger indoor lap lanes.





# New Event Arena and Hockey Training Center

- Public Private Partnership (P3) advisory services
  - Sports and entertainment P3 consultation
  - P3 legal consultation
  - P3 financial consultation
  - Hospitality, exhibition, and conference center consultation
- Site visits three locations
  - Acrisure Arena Palm Springs, CA
  - Baxter Arena Omaha, NE
  - Liberty First Credit Union Arena Ralston, NE
    - Lessons learned shared back of house, separate entrances in close proximity to each other, similar viewing/eating areas, and at grade concourse areas



### NEW EVENT ARENA & YOUTH HOCKEY TRAINING CENTER



- Event Arena
  - 8,000 hockey seating including suites / 9,000 concert
- Youth Hockey Training Center
  - 3 Ice sheets
  - +/- 1,500 seats in total
  - Shared restaurant/lounge
  - Room for expansion and multipurpose use
